What Is Covered: All defects in materials or workmanship, except slight imperfections in plastic or powder coating, on Atlantic South Plastics, Inc.'s Universal Plastic Tractor or Lawn Mower Top/Canopy properly installed per provided instructions.

For How Long: This warranty, and any implied warranties including merchantability and fitness for a particular purpose, last for one (1) year from the date of purchase if the attached Warranty Card is mailed in. The warranty is not transferable from the original purchaser.

What Atlantic South Plastics Will Do: During the applicable warranty period listed above, Atlantic South Plastics will, at its option, either repair or replace any defective product at no charge. You must pay any labor or shipping charges associated with removing or reinstalling the product. If a specific product has been discontinued, Atlantic South Plastics may, at its option, replace your product with a current product of comparable function and value.

What These Warranties Will Not Cover: These warranties do not cover any damage, defect, or malfunction caused by misuse, abuse, accident, improper installation, modification, improper or inadequate maintenance, or on-road and off-road hazards. Incidental and consequential damages are not recoverable under this warranty. **STEP 1 – SEE FIG. 2** Determine if Roll Over Protection System (ROPS) is forward leaning, straight, or rear leaning. This will determine the mounting holes used on canopy frame.

STEP 2 – SEE FIG. 3 Install (2) Angle Mounting Brackets to Canopy frame using (4) 5/16"x2" Hex Bolts, (8) 5/16" Flat Washers, and (4) 5/16"-18 Nylon Lock Nuts. \*\*NOTE\*\* MOUNTING PLATES CAN BE MOUNTED TO THE INSIDE OR OUTSIDE AND FRONT OR BACK HOLES OF THE CANOPY FRAME TO ACCOMMODATE YOUR ROPS POSITION.

**STEP 3 – SEE FIG. 4 The**(2) Angle Mounting Brackets can be mounted level or at a forward or rear angle to provide level canopy after installation.

**STEP 4 – SEE FIG. 5** With Assistance, raise Canopy assembly to the roll bar. Using (4) 3/8" Hex Bolts, (8) 3/8" Flat Washers, and (4) 3/8" Nylon Lock Nuts, attach (2) Flat Mounting Plates to (2) Angle Mounting Brackets with ROPS in-between.





**STEP 5 – SEE FIG. 6** Tighten all hardware securely.
